Article VII "Management" is hereby amended in its entirety to read as follows:

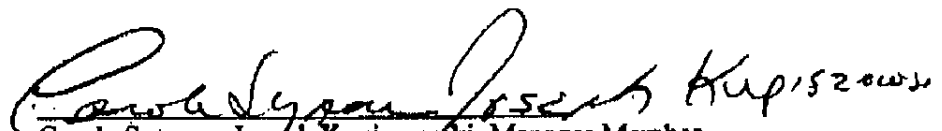
