**ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, sets forth the following:

**ARTICLE I - NAME**

**ARTICLE V - MEMBERSHIP UNITS**

The Company is authorized to issue One Hundred Thousand (100,000) Membership Units to its members to evidence their respective ownership interest in the profits and losses of the Company. **ARTICLE VI - ADDITIONAL MEMBERS**

An interest of a Member of the Company may only be transferred or assigned to such extent as is provided in the Operating Agreement.

**ARTICLE VII - MANAGEMENT**

The Company is to be managed by a manager or managers, and is therefore a manager-managed limited liability company. The initial Manager of the Company is Wayne A. Ritonour, Jr.

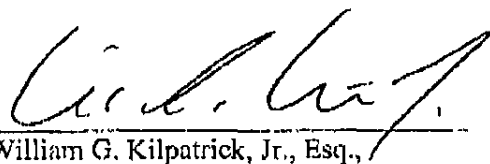

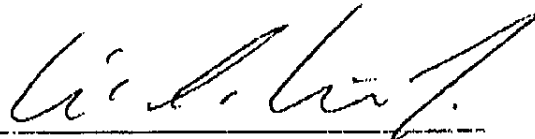
