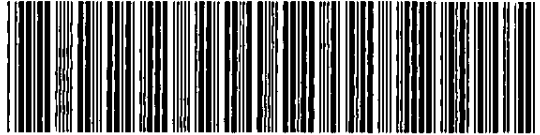

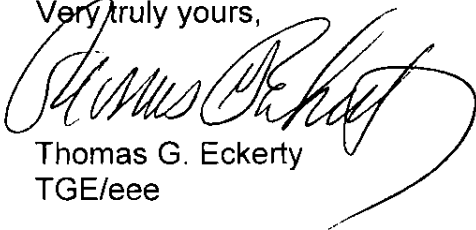

**ARTICLE I
Name and Address**

The name of the limited liability company shall be RMT PROPERTIES OF SW FLORIDA, LLC. The mailing and street address of the principle office of the limited liability company is: 6518 E. Town & River Road, Fort Myers, Florida 33914.

**ARTICLE II
Duration**

The company shall exist from the date of filing these Articles of Organization with the Department of State, and shall be dissolved upon the occurrence of any event of Dissolution as described in the Operating Agreement of the company, and if not so dissolved, shall be perpetual.

**ARTICLE III
Purpose**
