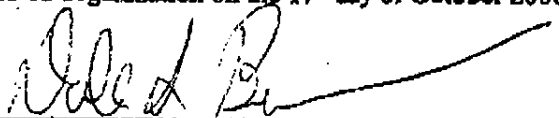
**ARTICLE III - MANAGEMENT**
