**ARTICLE I

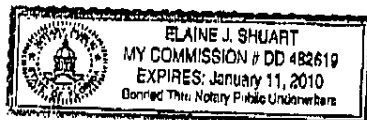




