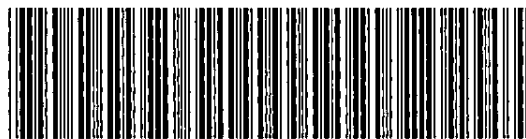

The undersigned, LINDA HULBERT, being the sole Member of **HULBERT HOMES REALTY, LLC**, a Florida limited liability company, does hereby certify that the following amendment to the Articles of Organization was adopted by the limited liability company:

RESOLVED that the Articles of Organization of **HULBERT HOMES REALTY, LLC**, be, and the same are hereby, amended so that Article VIII - Management is deleted in its entirety and the following Article VIII is substituted therefor:

The Company shall be managed by a Manager. The initial Manager shall be Akiko Wright, whose mailing address is 4030 S. Pipkin Road, Suite 100-A, Lakeland, Florida 33811. The signature of the Manager of the Company signing on behalf of the Company or the signature of a person designated as an officer of the Company under the Regulations may be relied on as sufficient evidence of the action of the Company and that such action has been authorized by the unanimous consent of the Members.

RESOLVED that the Articles of Organization of **HULBERT HOMES REALTY, LLC**, be, and the same are hereby, amended so that Article IX - Operating Agreement is deleted in its entirety and the following Article IX is substituted therefor:

The Members of the Company shall hereafter adopt the Operating Agreement also known as "Regulations" setting forth all the terms, provisions, conditions and covenants by which the Company will be governed. The power to adopt, alter, amend or repeal the Operating Agreement shall be vested in the Members of the Company by unanimous written consent.
