ARTICLES OF ORGANIZATION

OF

STERLING MINT LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be STERLING MINT LLC ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 8703 Cypress Mill Court, Tampa, Florida 33647 and the mailing address shall be Post Office Box 7874, Lakeland, Florida 33807-7874.
