OF

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

**ARTICLE I

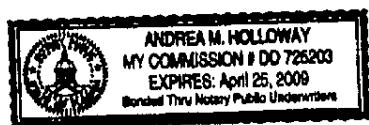
