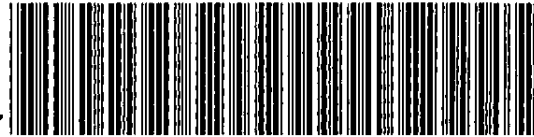

**ARTICLES OF ORGANIZATION
OF

ARTICLE I

Name and Address
