5. PERIOD OF DURATION.

The period of duration of the Company shall be from the date of filing of its

Articles of Organization until the first to occur of the following:

The Company and its officers, directors and shareholders understand and agree that the Registered Agent shall use his best reasonable efforts to timely forward to the Manager of the Company, or his, her or its written designee, all correspondence, notices and summonses received by the registered agent; provided, however, that the registered

agent shall have no other duty to respond to any such matters, or take any action, without the prior written instruction of the Company.

6. <u>ADDITIONAL MEMBERS</u>.

The Company shall have at least one (1) member, and may admit additional members upon the prior unanimous written agreement of the then existing members, or as otherwise provided in the Operating Agreement.

7. <u>CONTINUITY OF BUSINESS</u>.
