ARTICLE III

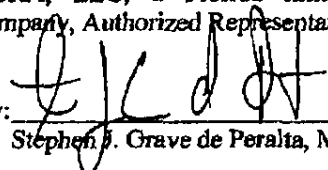

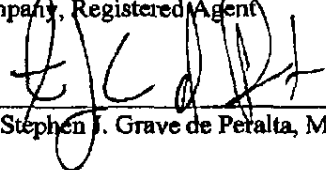
