ARTICLES OF ORGANIZATION OF KAHAN PREVENTIVE HEALTH CARE, P.L.

The undersigned subscriber to these Articles of Organization ("Articles"), being a natural person and competent to contract, hereby forms a Limited Liability Company under the laws of the State of Florida.

ARTICLE I. - NAME. Kahan Preventive Health Care, P.L. is the name of this Organization (hereinafter referred to as the "Company").

ARTICLE II. - PRINCIPAL OFFICE. The principal office of the Company is 3665 Madaca Lane, Tampa, Florida 33618.

ARTICLE III. - DURATION. The Company's existence commenced upon the filing of these Articles with the Florida Department of State, and the Company will exist perpetually, unless terminated in accordance with law.

ARTICLE IV. - PURPOSE. This professional limited liability company shall exclusively engage in rendering medical services through physicians that are duly licensed to render medical services. This professional limited liability company shall not engage in any business other than the rendering of medical services; however, this professional limited liability company shall not be prohibited from investing its funds and earnings in real estate, mortgages, stocks, bonds, or any other type of investment, or from owning real or personal property necessary for the rendering of medical services.


ARTICLE V. - CAPITAL. Contributions to the capital of the Company shall be made by the members, in the manner prescribed by the written Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

ARTICLE VI. - INITIAL REGISTERED OFFICE, AGENT AND ACCEPTANCE. The street address of the initial registered office of this company is 3665 Madaca Lane, Tampa, Florida 33618, and Bruce A. Kahan is the name of the initial registered agent of this Company at that address. The undersigned Registered Agent, by executing these Articles, states that such Registered Agent is familiar with and accepts the duties and responsibilities of Registered Agent for Kahan Preventive Health Care, P.L.

ARTICLE VII. - MANAGEMENT. The Company shall be a manager-managed company. The managers of Kahan Preventive Health Care, P.L. shall operate as a board of managers that shall be referred to as the Board of Directors. A member of the Board of Directors will retain such position until removed and replaced by the Members of the Company as provided in the Operating Agreement of the Company. The Board of Directors will have the obligations and responsibilities described in the Operating Agreement of the Company. The initial member of the Board of Directors is Bruce A. Kahan.

ARTICLE VIII. - MEMBER/MANAGER. The name and address of the person signing these Articles is Bruce A. Kahan, 3665 Madaca Lane, Tampa, Florida 33618.
