AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
CIRCLE SQUARE PARTNERS, LLC,
a Florida limited liability company

The undersigned, as the sole member of CIRCLE SQUARE PARTNERS, LLC, a Florida limited liability company (the "Company"), hereby amends and restates the Articles of Organization of the Company and certifies that:

1. The name of the Company is CIRCLE SQUARE PARTNERS, LLC.
2. Articles of Organization of the Company were originally filed with the Secretary of State of the State of Florida on October 29, 2008 and were assigned document number L08000101471.
3. These Amended and Restated Articles of Organization amend and restate the provisions of the Company's Articles of Organization, in their entirety, as follows:
