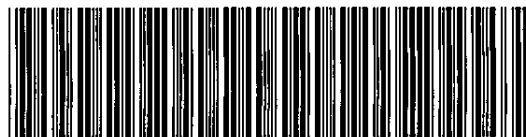

OF

ARTICLE I -- NAME


