

**ARTICLES OF ORGANIZATION
OF

These Articles of Organization are made for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (Ch. 608, Florida Statutes).

ARTICLE I

NAME

The name of this limited liability company is CHEDIAK INVESTMENTS, LLC (the "Company").

ARTICLE II

DURATION

The Company shall exist from the date of filing these Articles of Organization with the Department of State until the earlier of 90 years from the date of filing or the occurrence of any of any of the events specified in Section 608.441, Florida Statutes (2007), unless continued by the unanimous consent of all of the remaining members.


ARTICLE III

**ARTICLE IV****REGISTERED AGENT AND OFFICE**

The name of the initial registered agent of the Company is LARRY M. SEGALL, and the street address of the initial registered office of the Company is 3321 Henderson Blvd., Tampa, Florida 33609.

ARTICLE V**ADDITIONAL MEMBERS**

Additional members may be admitted and membership interests may be transferred, but only if all of the current members agree to the admission of the additional members and to the terms of admission and transfer, in accordance with the provisions of the Operating Agreement.

ARTICLE VI**TERMINATION OF MEMBERSHIP**

Upon the death, legal disability, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless the remaining members, by unanimous written agreement, consent to continue the business of the Company.

ARTICLE VII**MANAGEMENT OF THE COMPANY**

The Company shall be managed by the Managers in accordance with the Company's Operating Agreement, and is therefore a manager-managed

The Company shall initially be managed by the following managers until the first meeting of the members or until successors are elected and qualified: Jose Antonio Burruezo, Jr., whose mailing address is 9004 Cliff Lake Lane, Tampa, FL 33614 and Edmundo Alberto Burruezo, whose mailing address is 14543 Pleach St., Winter Garden, FL 34787.

ARTICLE VIII
REGULATIONS

The members shall have the power to adopt, alter, amend or repeal an Operating Agreement for the Company containing provisions for the regulation and management of the affairs of the Company.

ARTICLE IX
DATE OF EXISTENCE OF THE COMPANY

The existence of the Company shall commence on the date of filing of the subscription and acknowledgment of the Articles of Organization.

ARTICLE X
POWERS

The Company shall have all powers as are provided in Section 608.404, Florida Statutes (2007), and such other powers as are set forth in the Operating Agreement of the Company.
