STACKHOUSE, a natural person competent to contract and an authorized representative of a member of THE PATHOLOGY GROUP OF NORTHWEST FLORIDA, PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 608, *Florida Statutes*.

ARTICLE I

The name of the professional limited liability company is:

The Company shall be managed by its members as provided in the Company's Operating Agreement.


ARTICLE VII - RESTRICTION ON MEMBERSHIP
