Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State, the following are the Articles of Organization for Sefton Investments LLC (the "Company")

1. Name. The name of the Company is Sefton Investments LLC.
