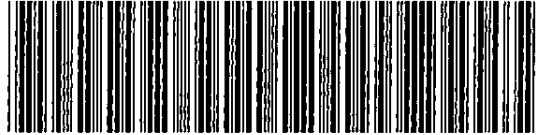

Articles of Organization
of

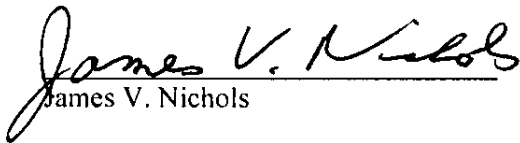

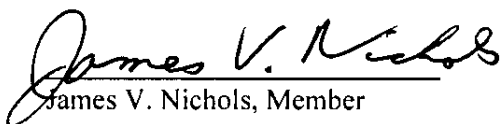
