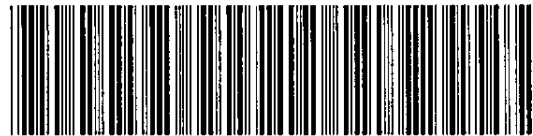



ARTICLE IV – TRANSFERABILITY OF MEMBERSHIP INTERESTS




