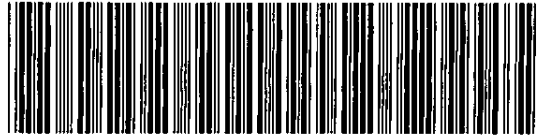

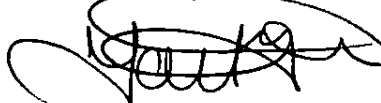

**ARTICLES OF ORGANIZATION
OF
FISHER TWO, LLC**

ARTICLE I

Name

The name of the limited liability company is Fisher Two, LLC (the "Company").

ARTICLE II

Duration

The existence of the Company shall be perpetual.

ARTICLE III

Principal Office

The mailing address and the street address of the principal office of the Company is 7100 Fisher Island Drive, Unit 7191, Fisher Island, Florida 33109.

ARTICLE IV

Initial Registered Office and Registered Agent

**Restrictions on Membership and
