- 1. My name is Stephen E. Childs. I am over the age of 18 and fully competent to make this affidavit. I have personal knowledge of the facts stated in this affidavit. All facts in this affidavit are true and correct to the best of my knowledge.
- 2. I am 50% Member and Chief Executive Manager of TALIAFERO &VIGLIONE, LLC.
- 3. I make this affidavit in support of an investigation that I am demanding from the Florida Secretary of State, Division of Corporations, Corporate filings office, and like state, federal and legal firms & agencies.
- 4. On November 2, 2008, I entered into and caused to be executed a preorganization agreement (Operating Agreement) with Adele Childs to form TALIAFERO & VIGLONE, LLC., a civil judgment enforcement firm. [See: Ex. A]
- 5. The names of TALIAFERO & VIGLIONE, represent our mothers' maiden names. As my mother's maiden name is Taliaferro and Adele's mother's maiden name is Viglione.

- 6. We are the only members of the LLC. These names were chosen by the Members respectively and agreed to through the express contract mainly the operating agreement. [Id. Ex. A, Art. 1.2]
- 7. Upon entering into the agreement as 50% Member, I accepted the Office of Chief Executive Manager as defined by the Operating Agreement, and TALIAFERO & VIGLIONE, LLC was elected by the members to be a Manager-Managed LLC. [Id. Exhibit A, Art. 7]
- 8. The only offices created and defined in the operating agreement was that of Chief Executive Manager, who is noted as the Operations Manager in the Articles of Organization. No other office was created nor defined by the Members. [Id. Art 4 @ 4.4 & See: Exhibit B, Art. 9]
- 9. TALIAFERO & VIGLIONE, LLC was formed by filing with the Florida Secretary of State, its Articles of Organization on November 6th 2008, through its resident agent Spiegel & Ultrera. P.A. of Miamí, Florida. **[Id. Exhibit B]**
- 10. No other members were ever added to the LLC., nor did I accept any other members into the LLC by unanimous agreement as defined by the Operating Agreement of TALIAFERO & VIGLIONE, LLC.
- 11. TALIAFERO & VIGLIONE, LLC has been operational on a continuous basis since its organization on November 6th, 2008.
- 12. The organic filing document, its Articles of Organization and the Operating Agreement are express agreements that have ever been supplemented, amended, changed or revised by a resolution of the members or otherwise.
- 13. I have never authorized the creation of the office of "President" within TALIAFERO & VIGLONE, LLC by express agreement, resolution, nor through parol

evidence or acquiescence. Nor have I authorized the expansion of any office within TALIAFERO & VIGLONE, LLC., into the office of President.

14. Any other office that has been placed on record aside from the office created by the express agreement memorialized in the Operating Agreement or Articles of Organization constitutes a fraudulent misrepresentation of the offices of TALIAFERO & VIGLIONE, LLC.
