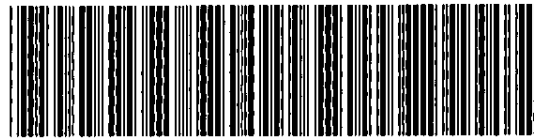

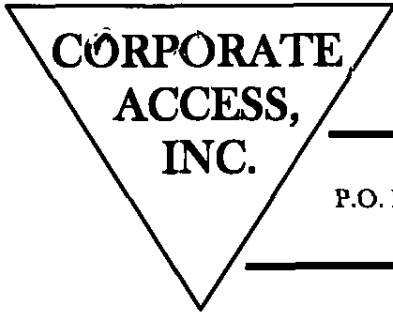

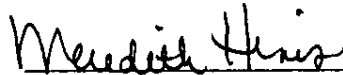
ARTICLE IV - MANAGEMENT

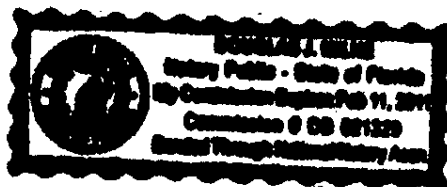
