Articles of Organization

ARTICLES OF ORGANIZATION OF SCHNAARS REALTY, LLC

The undersigned, for the purpose of forming a limited liability stompany under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be SCHNAARS REALTY, LLC ("company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is GERARD SCHNAARS 532 Serenity Place, Lake Mary FL 32746.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 
