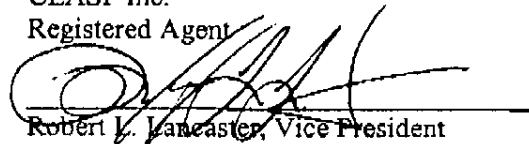

Authority of Members

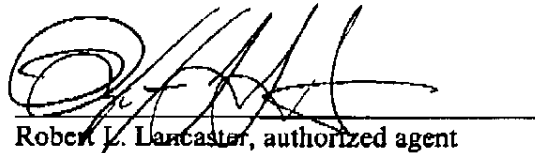
