ARTICLES OF ORGANIZATION OF ATEILUJ, LLC

The undersigned, being a duly authorized representative of the members, desiring to form a limited liability company under and pursuant to the Florid Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopted the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is ATEILUJ, LLC The Company").

ARTICLE II

ADDRESS

ARTICLE III

REGISTERED AGENT AND OFFICE
