ARTICLES OF ORGANIZATION

ARTICLE V: PURPOSE.

THE LIMITED LIABILITY COMPANY IS ORGANIZED EXCLUSIVELY FOR CHARITABLE AND EDUCATIONAL PURPOSES FOR THE FURTHERANCE OF ATHLETIC AND PHYSICAL FITNESS GOALS.

ARTICLE V: NO PART OF THE NET EARNINGS OF THE LLC SHALL INURE TO THE BENEFIT OF OR BE DISTRIBUTED TO ITS MEMBERS. TRUSTEES, OFFICERS OR OTHER PRIVATE PERSONS, EXCEPT THAT THE LLC SHALL BE EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF THE PURPOSE SET FORTH IN ARTICLE V. ABOVE. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE LLC SHALL BE IN THE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND -THE LLC SHALL NOT PARTICIPATE IN OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OF OR IN OPPOSITION TO ANY CANDIDATE FOR PUBLIC OFFICE. THE LLC SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(c)(3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. ALSO, THE LLC WILL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170(c)(2) OF THE INTERNAL REVENUE CODE OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

ARTICLE VI: DISSOLUTION.

UPON THE DISSOLUTION OF THE LLC, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE OF THE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(c)(3) OF THE INTERNAL REVENUE CODE OR THE CORRESPONDING SECTION OF ANY FUTURE TAX CODE. OR, THEY MAY BE DISTRIBUTED TO FEDERAL OR LOCAL GOVERNMENT FOR A PUBLIC PURPOSE. ANY SUCH ASSETS NOT SO DISTRIBUTED SHALL BE DISPOSED OF BY A COURT OF COMPETENT JURISDICTION OF THE COUNTY, IN WHICH THE LLC IS LOCATED, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATIONS AS THE COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCUSIVELY FOR SUCH PURPOSE.
