# ARTICLES OF ORGANIZATION OF NWR SOULARD, LLC

Under the Florida Limited Liability Company Act

## ARTICLE I

The name of this limited liability company is NWR SOULARD, LLC (hereinafter "the Company").

### MAILING AND STREET ADDRESS

The mailing and street address of the principal office of the Company is 4311 NW 75th Avenue, Coral Springs, FL. 33065.

### ARTICLE III DURATION

The period of duration for the Company is perpetual, except that the retirement, resignation, expulsion, bankruptcy, dissolution or death of a member, or the occurrence of any other evant, which terminates the continued membership of a member in the Company shall dissolve the Company unless a majority in interest of the termination of the business of the Company.

#### ARTICLE VI MEMBERS CANNOT BIND THE COMPANY

This Company is managed exclusively by a Manager, and members have no authority to bind it.

### ARTICLE VII ADMISSION OF ADDITIONAL MEMBERS

Members of the Company have the right to admit new members only upon the written consent of all existing members, and the existing members shall determine the amount and nature of contributions by new members at the time new members are admitted. An assignee of a member's interest in the Company may become a member only if all existing members consent in writing.

### ARTICLE VIII INVOLUNTARY ASSIGNMENT OF MEMBER INTEREST

In the event that a Member's interest in the Company is taken involuntarily, by levy, foreclosure, charging order, execution, or other similar proceeding, the Company shall not dissolve. The assignee of the Member's interest shall be entitled to no more than to receive the profits and losses attributable to said interest and shall not be entitled to participate in any respect in the management or administration of the Company's business or affairs.

### ARTICLE IX LIMITATION ON MEMBER WITHDRAWAL

No Member of the Company has the right to withdraw of Teduce his capital contribution to the Company except upon the written consent of all existing members.

#### ARTICLE X BUSINESS PURPOSE

The purpose of the Company is to engage in any lamble lett or activity for which a limited liability company may be organized under the Florida Limited Liability Company Act, as amended from time to time.
