**ARTICLES OF ORGANIZATION
OF
UNDERWOOD DATA SYSTEMS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be **UNDERWOOD DATA SYSTEMS, LLC** (the "Company"). The principal place of business of the Company in Florida and the mailing address of the Company shall be 830-13 A-1-A North, Ponte Vedra Beach, Florida 32082.

**ARTICLE II
DURATION**

The Company shall commence its existence on the date these Articles of Organization are executed. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in the Operating Agreement of the Company.

**ARTICLE III
PURPOSES AND POWERS**
