**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
CNL GLOBAL GROWTH SUB-MANAGERS, LLC**

Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, **CNL GLOBAL GROWTH SUB-MANAGERS, LLC** adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the limited liability company is **CNL GLOBAL GROWTH SUB-MANAGERS, LLC** (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on November 12, 2008, and Articles of Amendment of the Company were filed with the Florida Department of State on June 30, 2011, under Document Number L08000105371.

THIRD: Article IV of the Company's Articles of Organization shall be added in its entirety as follows:

"ARTICLE IV - MANAGEMENT"
