"Article II - Address. The mailing address and street address of the principal office of the Limited Liability Company is: 17430 Alico Center Road, Ft. Myers, FL 33967."

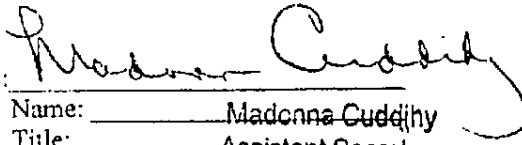
(b) The undersigned desires to amend Article III of the Articles by hereby deleting the current text in its entirety and substituting the following in lieu thereof:

"Article IV – Management. The Limited Liability Company is to be member-managed."

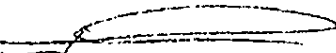
(d) The undersigned desires to amend Article V of the Articles by hereby deleting the current text in its entirety and substituting the following in lieu thereof:
