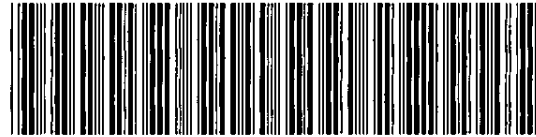

ARTICLE I. Name: The name of the Limited Liability Company is MF 305, (the "Company").




