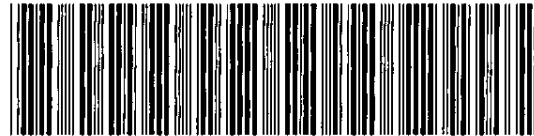

**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I - NAME**
