**ARTICLES OF ORGANIZATION  
OF  
NORTHWEST FLORIDA CENTER

The undersigned organizer, pursuant to Section 608.407 Florida Statutes, as amended, does hereby adopt the following Articles of Organization for such limited liability company (the "Company").

**ARTICLE I - NAME**

The name of the Limited Liability Company shall be **NORTHWEST FLORIDA CENTER FOR FOREIGN INVESTMENT, L.L.C.** and the street and mailing address of the Company is 720 Fifth Avenue South, Suite 211, Naples, Florida 34102.


