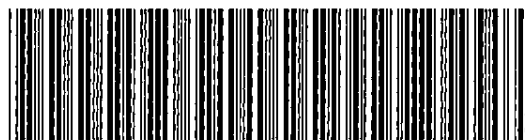

The Company is to be member-managed and the name and address of the initial managing member is:




