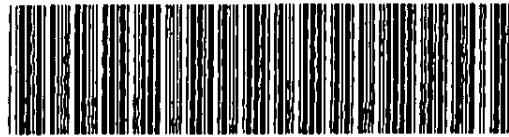

ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY
CERTIFICATE OF ORGANIZATION

Pursuant to the provisions of the Florida Limited Liability Company Act (the Act), the undersigned, desiring to organize a Florida limited liability company, hereby certify as follows:

1. *Federal Employer Identification Number.* The limited liability company organized hereby has applied for (but not yet received) a federal employer identification number.
2. *Name of the Limited Liability Company.* The name of the limited liability company formed hereby (the "LLC") is **KJ GALLUP REALTY LLC**.
3. *Office of the Limited Liability Company.* The address of the office of the LLC for purposes of Section 415 of the Act is 475 NE Bayberry Lane, Jensen, Florida 34957.
