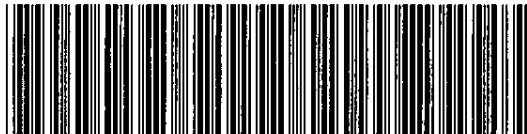



**ARTICLES OF ORGANIZATION**

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I. NAME**

The name of the limited liability company is POST & GONZALEZ, P.L. (the "Company").

**ARTICLE III. DURATION AND CONTINUATION**

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Regulations, (ii) by the written agreement of a majority in interest of its Members, (iii) by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or (iv) upon the occurrence of any other event which terminates the continued membership of a Member. However, except for a termination event described in (i) and (ii), the existence and business of the Company may be continued with the consent of a majority in interest of the remaining Members of the Company, or by amendment of these Articles of Organization providing for the continued existence of the Company.

**ARTICLE IV. PURPOSE**

The purpose for which the Company is being formed is to practice law as well as to engage in any activity or business permitted under the laws of the State of Florida.

## ARTICLE V. REGISTERED AGENT AND OFFICE

The Company designates 66 West Flagler Street, Suite 300, Miami, Florida 33130 as the street address of the initial registered office of the Company and names THOMAS R. POST as the Company's initial registered agent at that address to accept service of process within this state.

## ARTICLE VI. MANAGEMENT
