ARTICLES OF AMENDMENT ARTICLES OF ORGANIZATION TRADITIONS HEALTH CARE, LLC

Pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act, Traditions Health Care, LLC adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the limited liability company is Traditions Health Care, LLC (the "Company").
