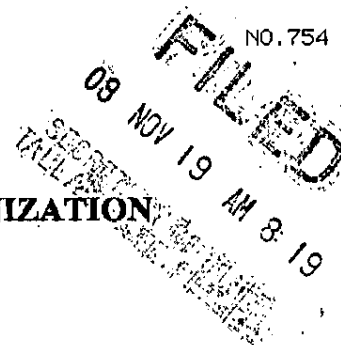

ARTICLES OF ORGANIZATION
FOR

ARTICLE I - Name
