ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF URBANA PELICAN GRAND II LLC

Pursuant to the provisions of section 608.411, Florida Statutes, URBANA PELICAN GRAND II LLC, adopts the following amendment to its Articles of Organization:

FIRST: The name of this Florida limited liability company as filed with the Florida Department of State is URBANA PELICAN GRAND II LLC (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on November 19, 2008 and assigned Document Number L08000107586. The Articles of Organization were amended on October 5, 2011 and again on January 6, 2012.

THIRD: The Articles of Organization of the Company are hereby amended as follows:

1. <u>Change of Name:</u> Article 1 of the Articles of Organization is amended to change the Company's name. The new name of the limited liability company is:

FOURTH: Except as amended above, the Articles of Organization of the Company, as filed with the Florida Department of State, shall remain in full force and effect.

FIFTH: The foregoing amendment was approved on January 31, 2012 by written consent of the sole (100%) member owning all of the membership interests in the Company.
