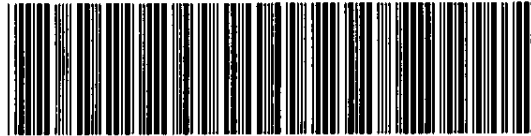


**Article Three



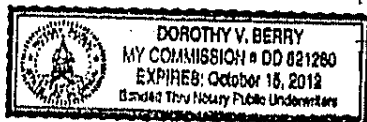
