- FIRST:** The name and address of this Company is **CARDIO VASCULAR IMAGERY, LLC**, 8870 North Himes Avenue, Suite 647, Tampa, Florida 33614.
- SECOND:** The date of the adoption of these Articles of Dissolution is September 25, 2009.
- THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
