ARTICLE I - PRINCIPAL OFFICE

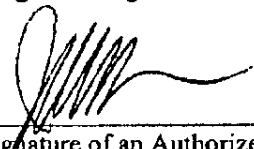

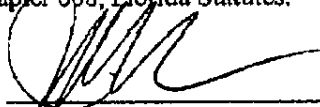
