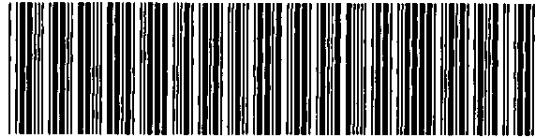


ARTICLE II – Mailing Address

ARTICLE V – No Personal Liability


