Article I. Name

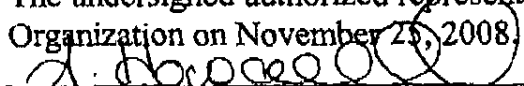

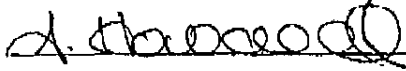
