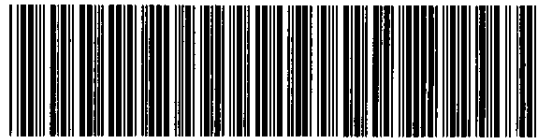

The purpose for which this Limited Liability Company is organized is: Any and all lawful business.




