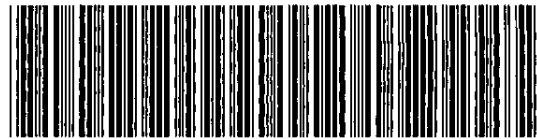

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be 4548 NE 6 AVE, LLC.

ARTICLE II - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual from the date that these Articles of Organization are filed with the Florida Department of State, unless the Company is earlier dissolved as provided in these Articles of Organization, or by law.

ARTICLE III - MAILING ADDRESS AND STREET ADDRESS

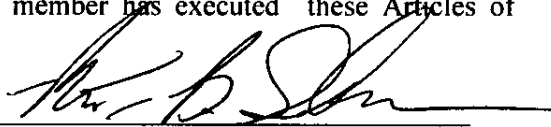
