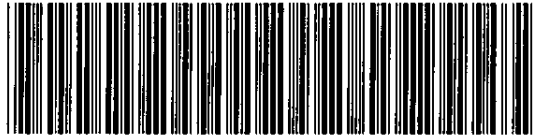




ARTICLE VII
