ARTICLE I - NAME

ARTICLE VIII - MANAGEMENT



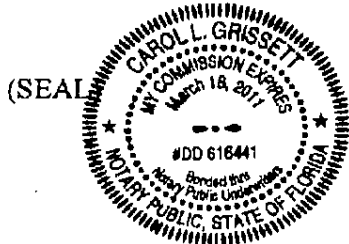
The power to adopt, alter, amend or repeal the regulations of the Company is vested entirely in the Members of the Company


