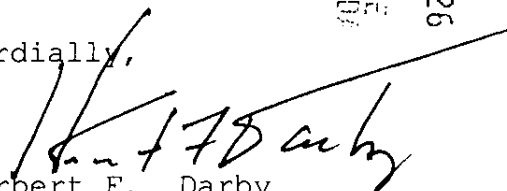

**ARTICLES OF ORGANIZATION
OF

The undersigned individual hereby adopts these Articles of Organization in order to form a limited liability company under Chapters 608, Florida Statutes.

**ARTICLE I
NAME**

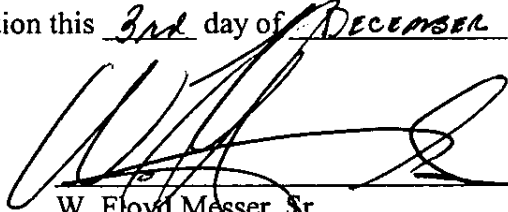
ARTICLE VI

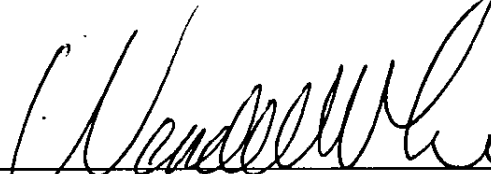
