ARTICLES OF ORGANIZATION OF HICKS HOLDINGS, LLC

The undersigned authorized representative of a member of the captioned Limited Liability

Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization
